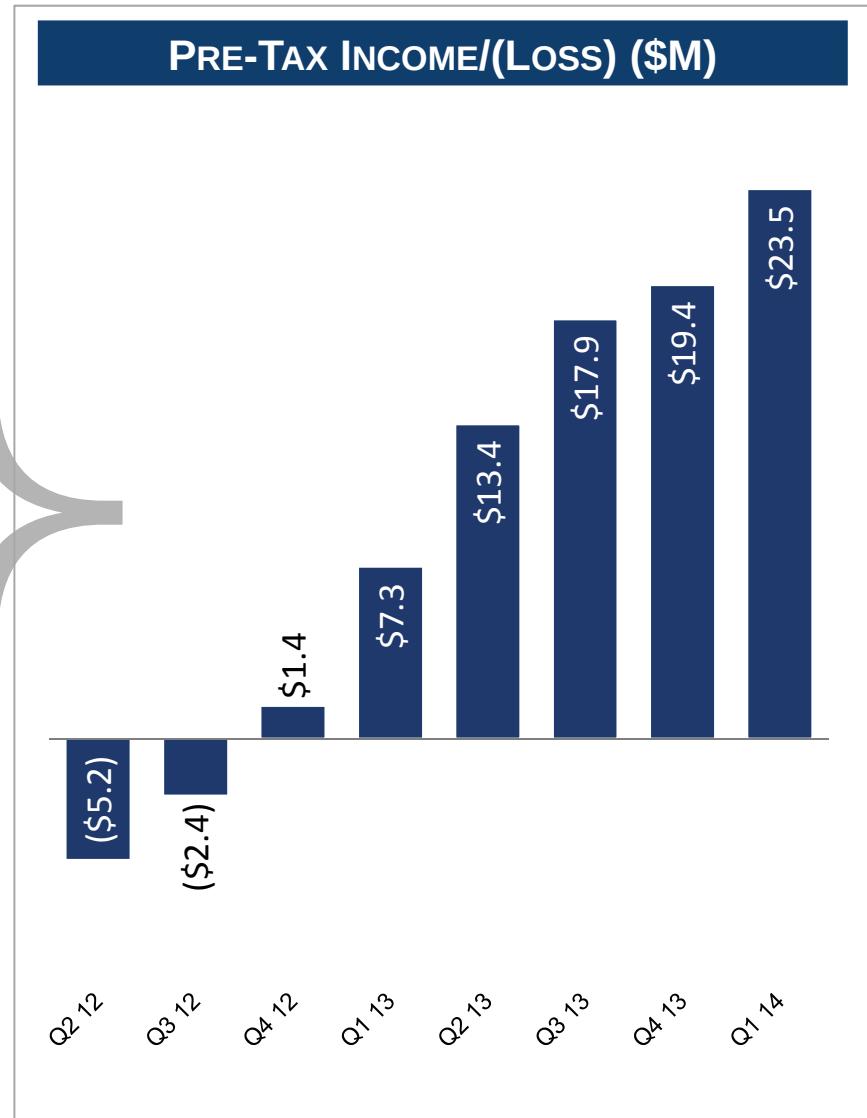
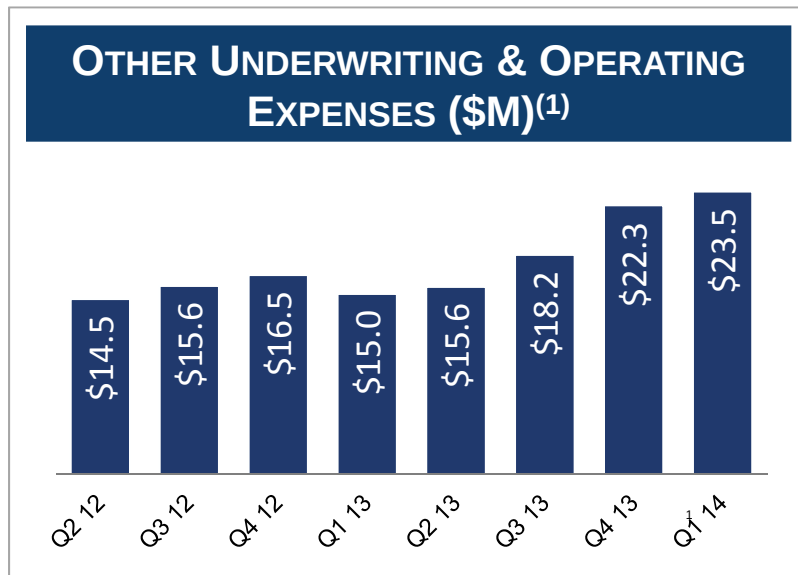
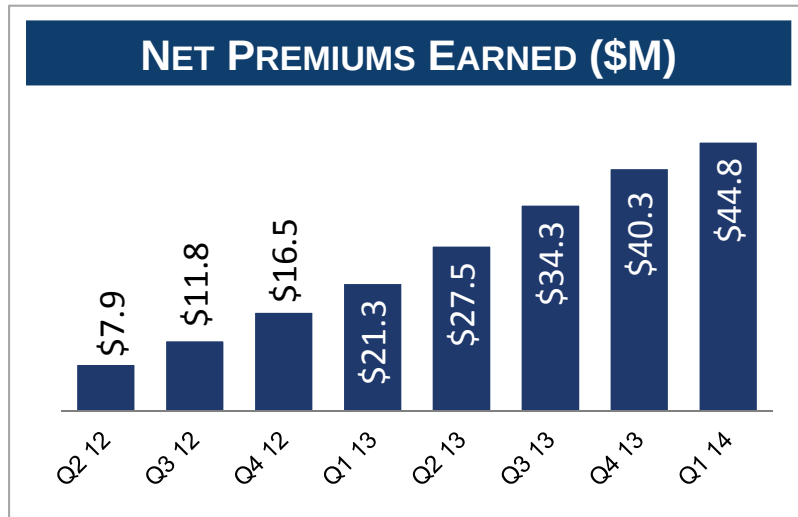
Who Is Essent?

- Combined risk to capital ratio of 16.1:1⁽¹⁾



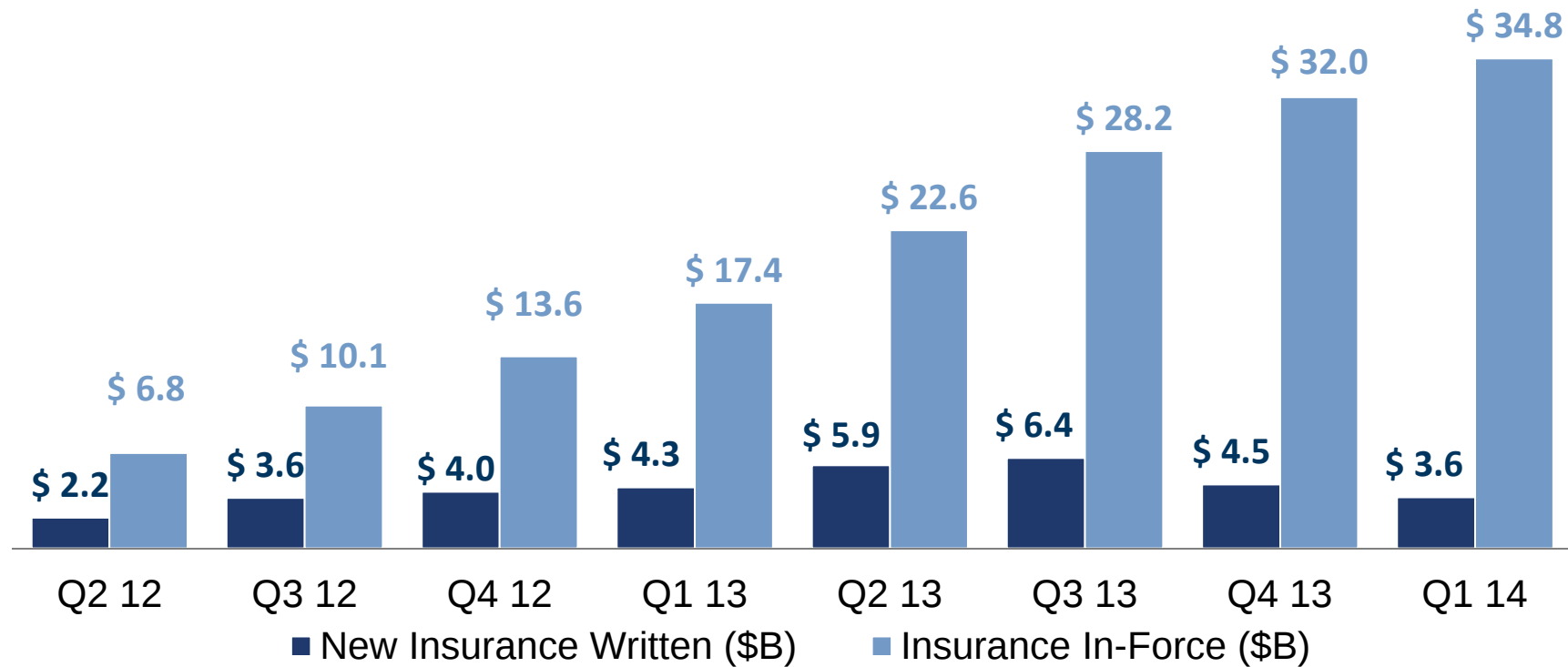

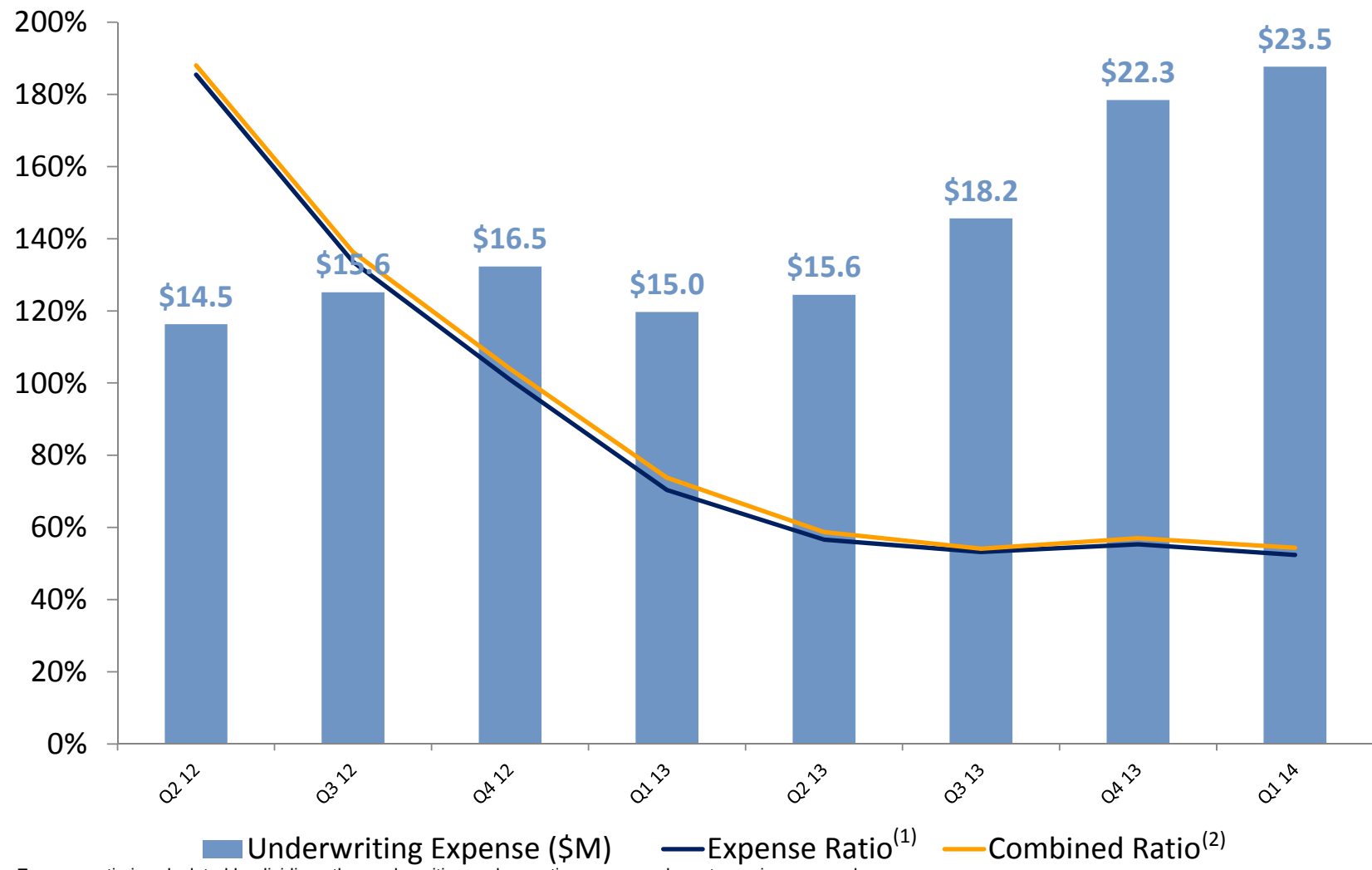

Underwriting Expenses



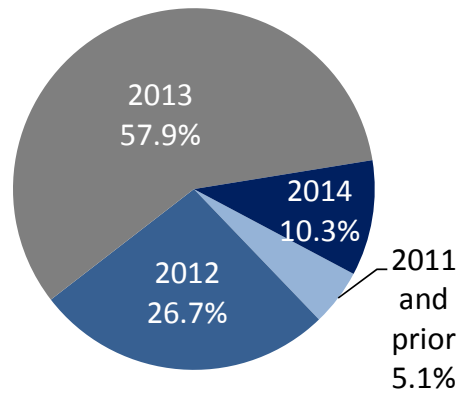
(1) Expense ratio is calculated by dividing other underwriting and operating expenses by net premiums earned.

(2) Loss ratio plus expense ratio.

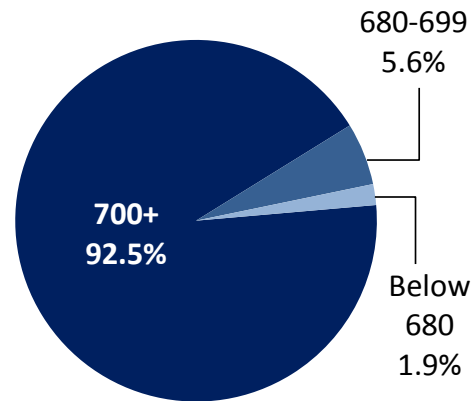
In Force Portfolio

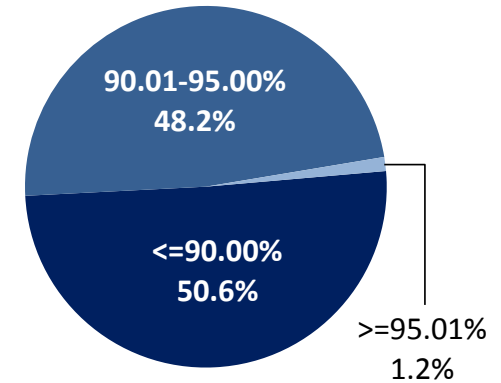
IIF BY VINTAGE



IIF by FICO Score

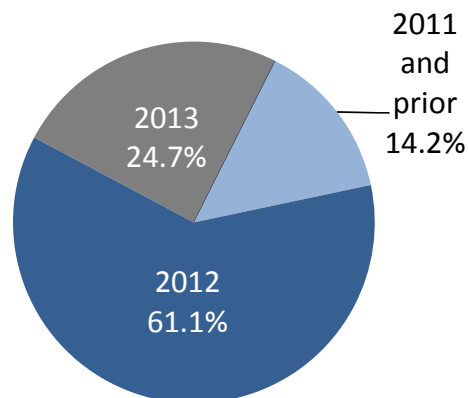


IIF BY LTV

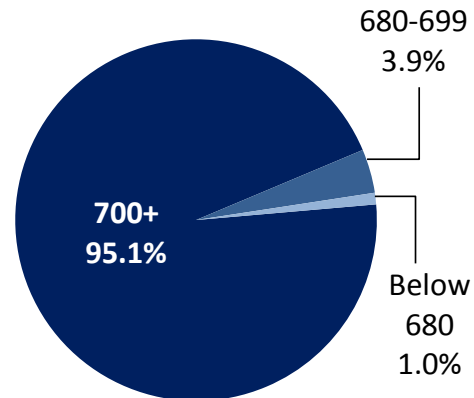

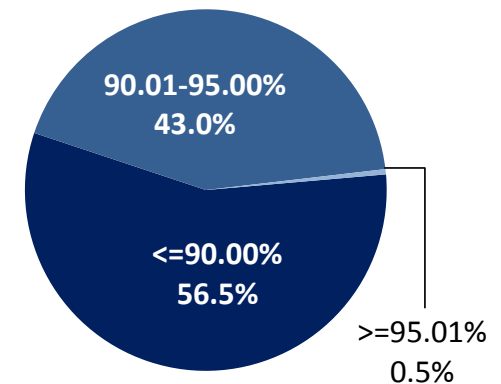

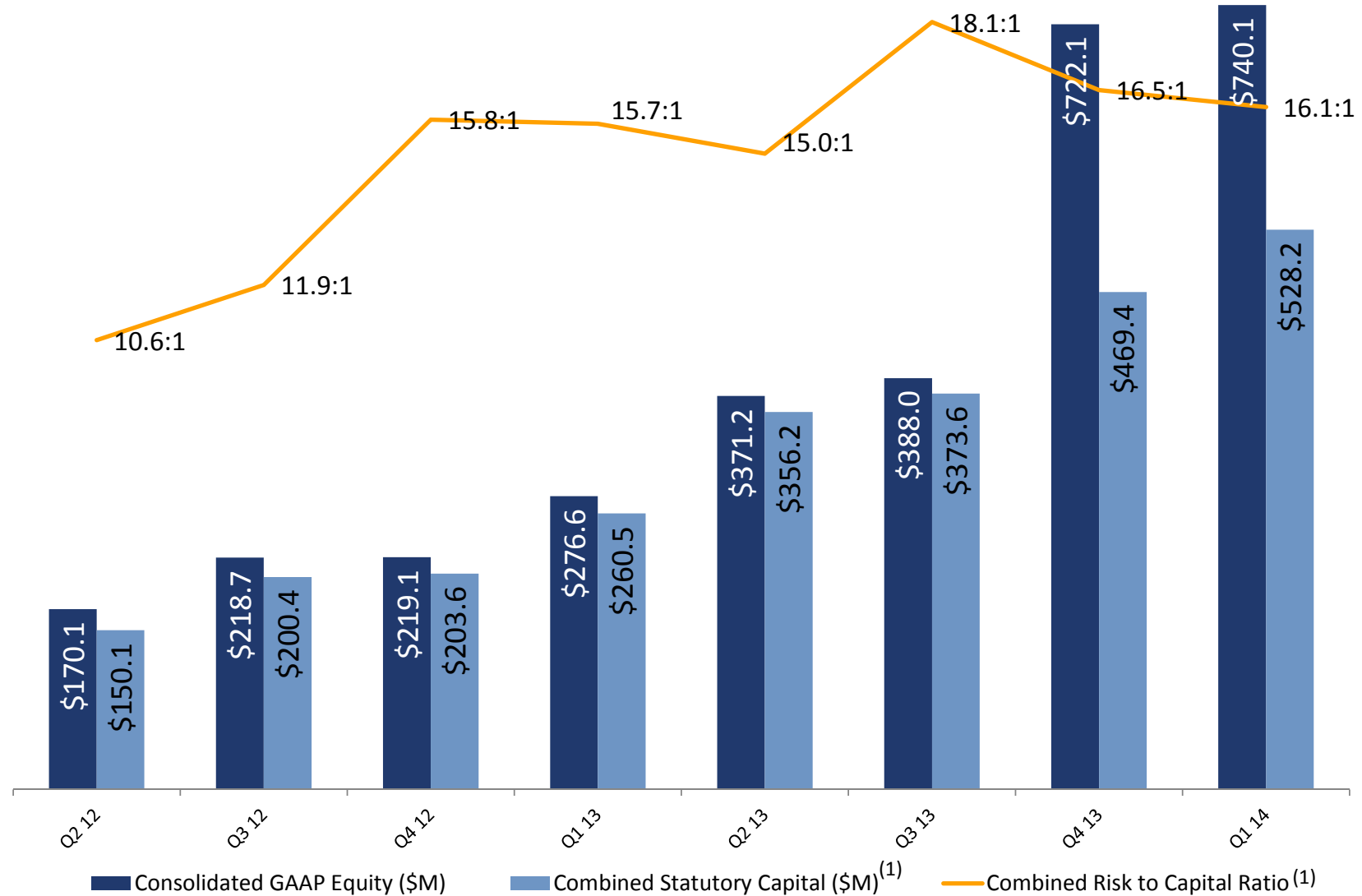
