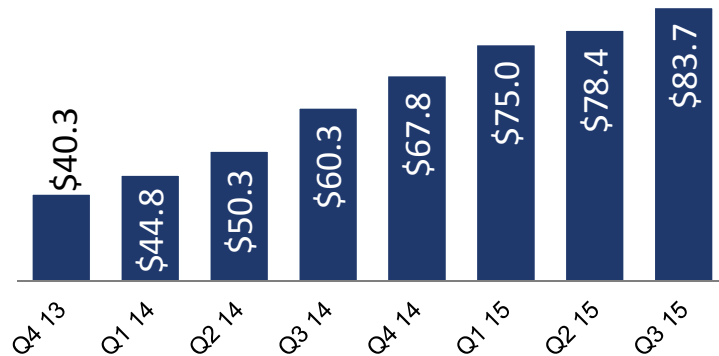
- Essent Group Ltd. is a Bermuda-based holding company (NYSE: ESNT)

- Combined risk to capital ratio of 15.4:1⁽¹⁾



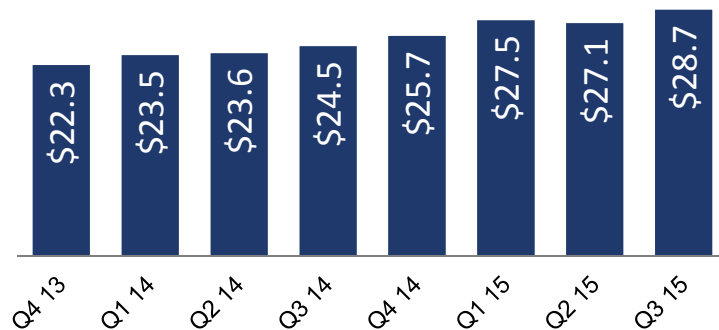

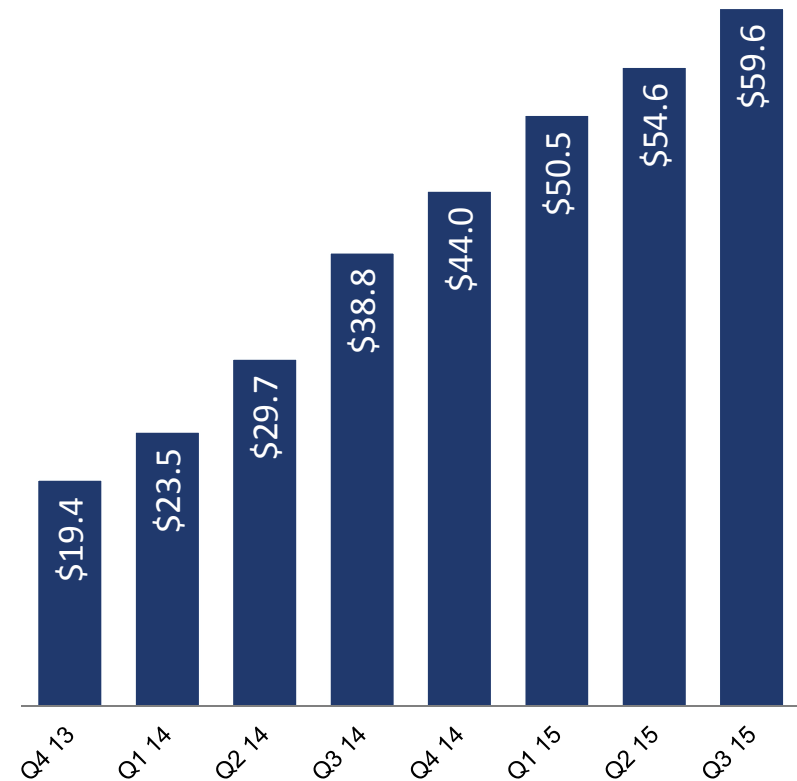
NET PREMIUMS EARNED (\$M)



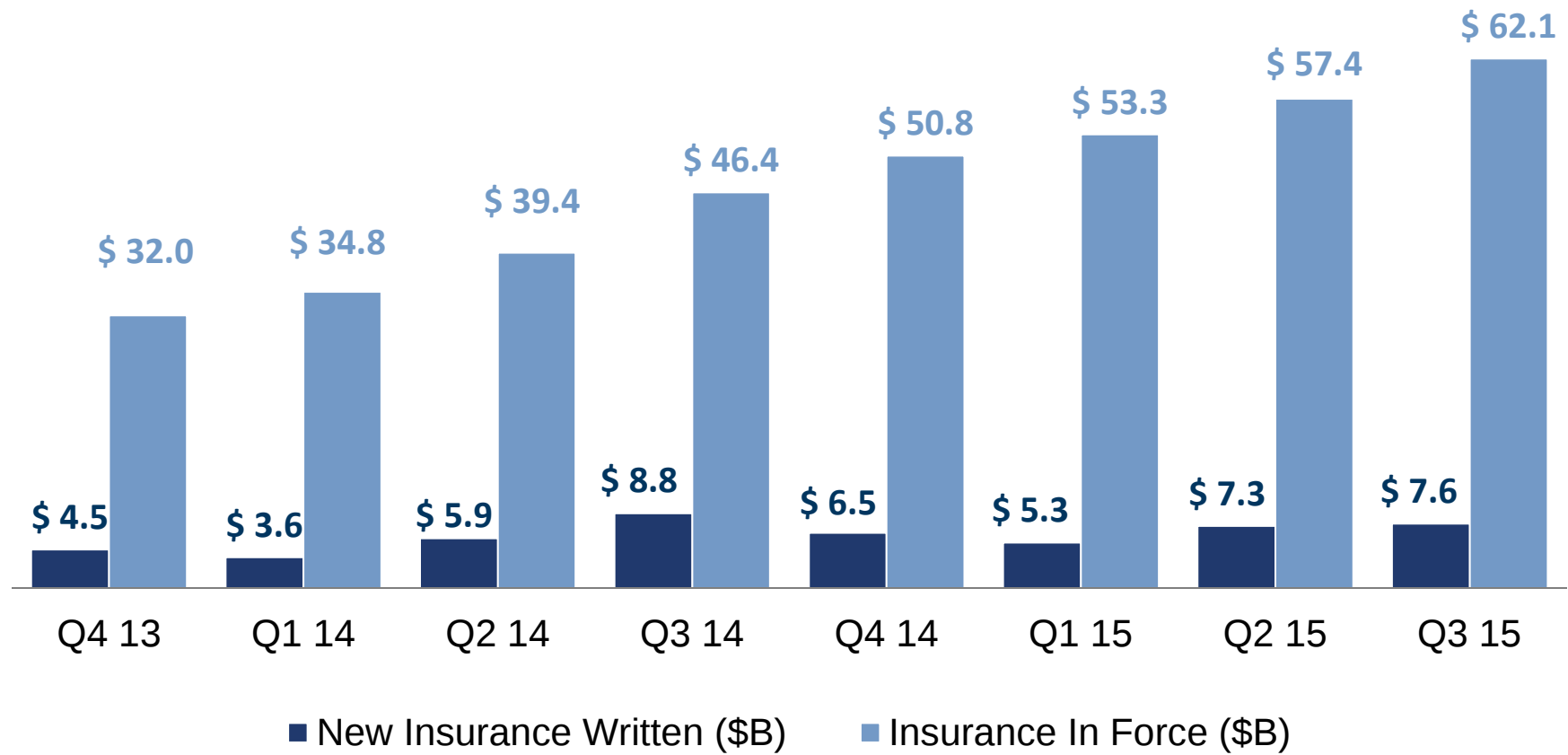
OTHER UNDERWRITING & OPERATING EXPENSES (\$M)



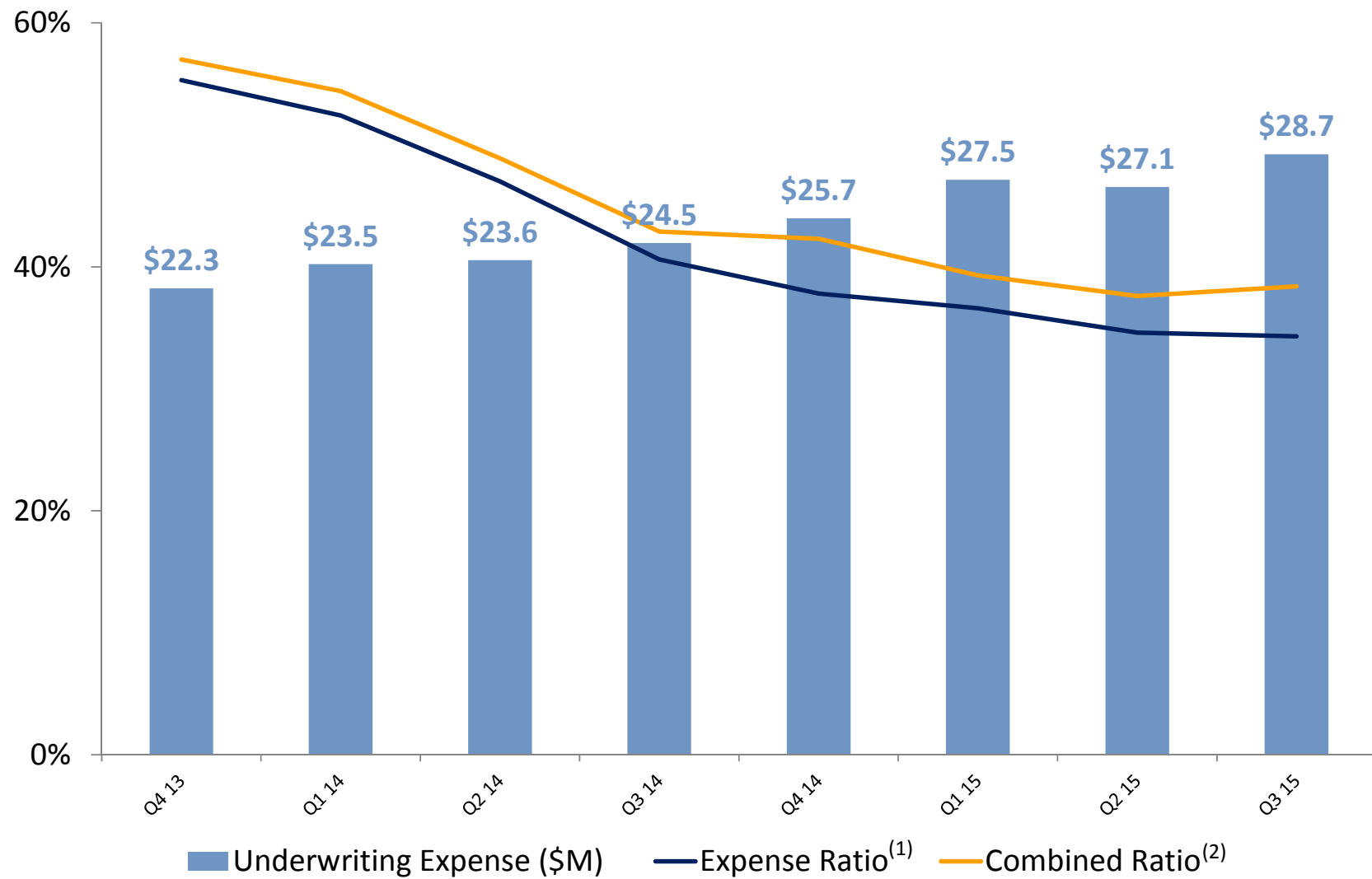
PRE-TAX INCOME (\$M)

Underwriting Expenses



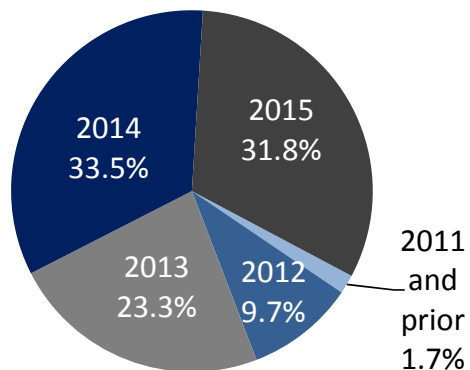

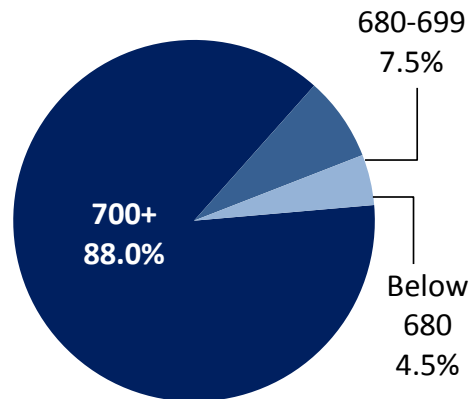

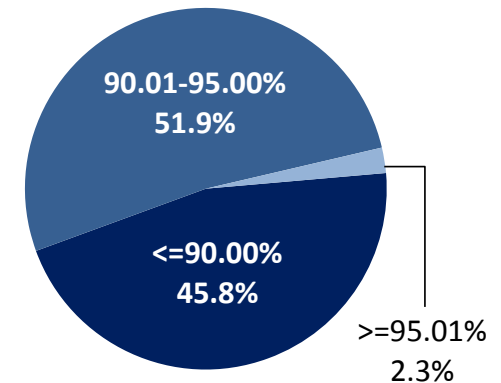
IIF BY VINTAGE



IIF by FICO Score

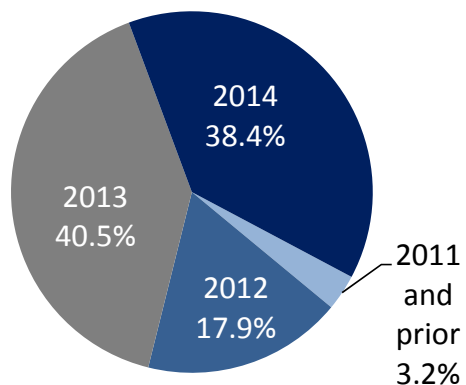


IIF BY LTV

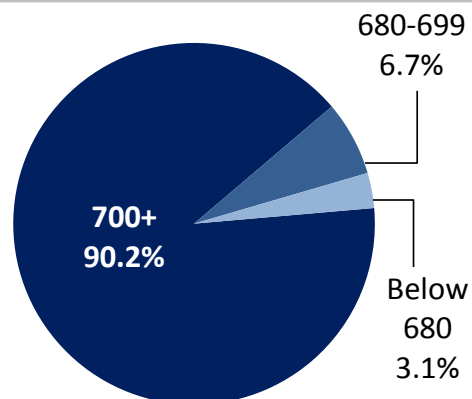


\$46.4 BILLION AS OF SEPTEMBER 30, 2014

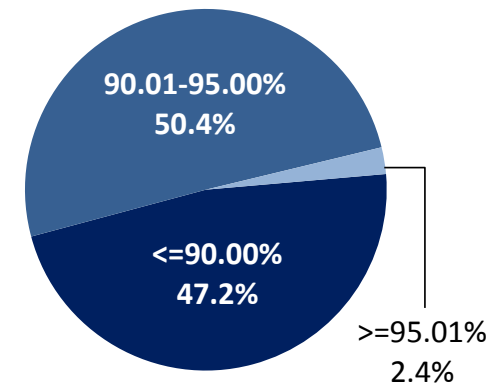

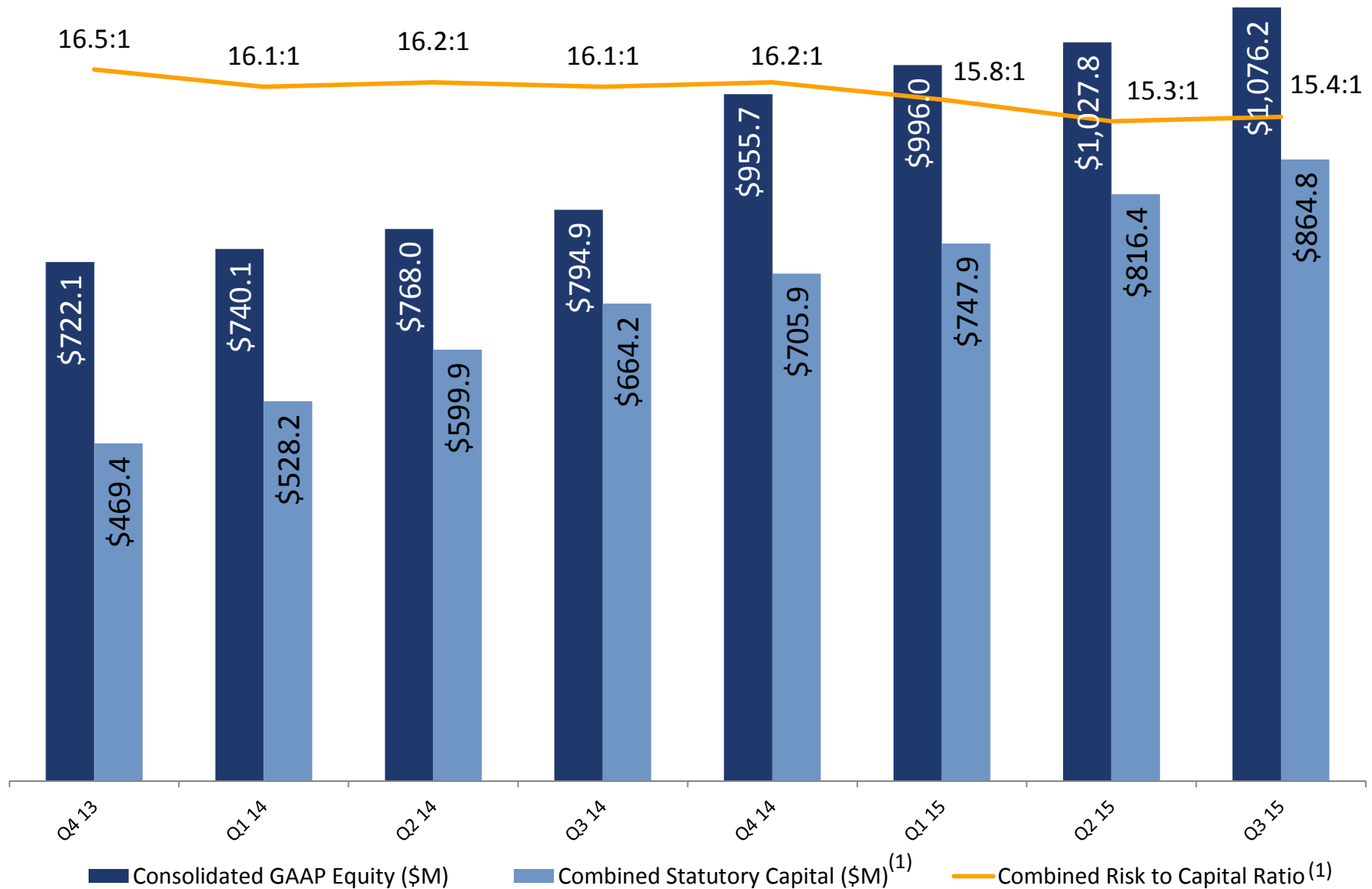
IIF by FICO Score
