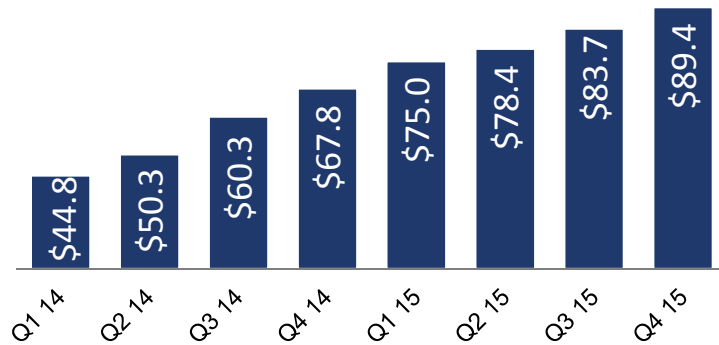

- Combined risk to capital ratio of 15.2:1⁽¹⁾



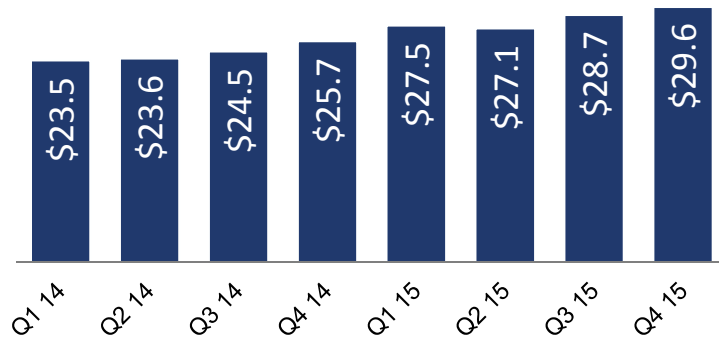

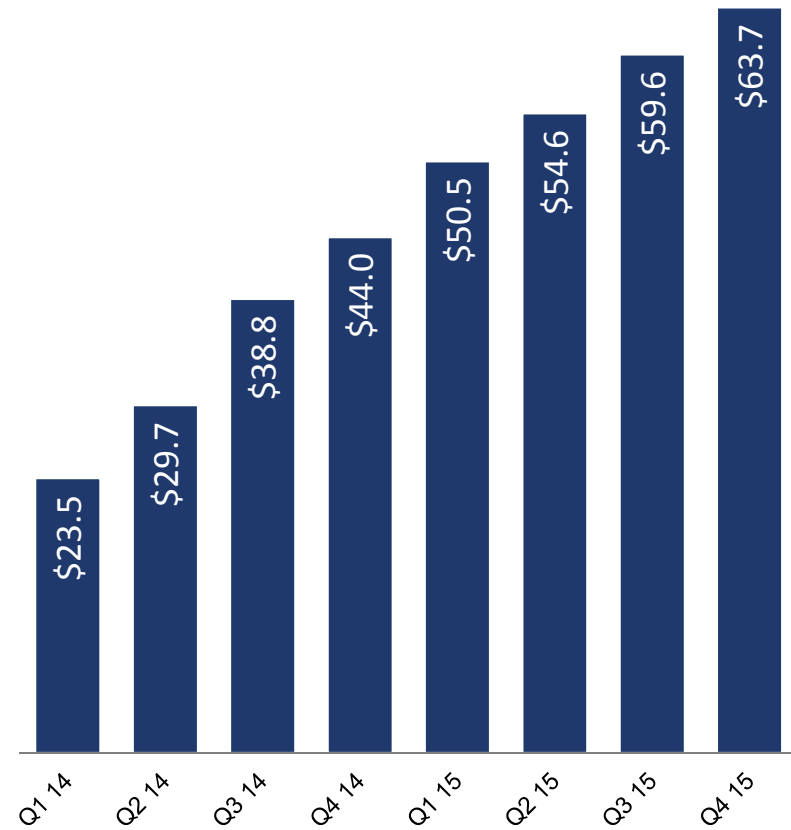
NET PREMIUMS EARNED (\$M)



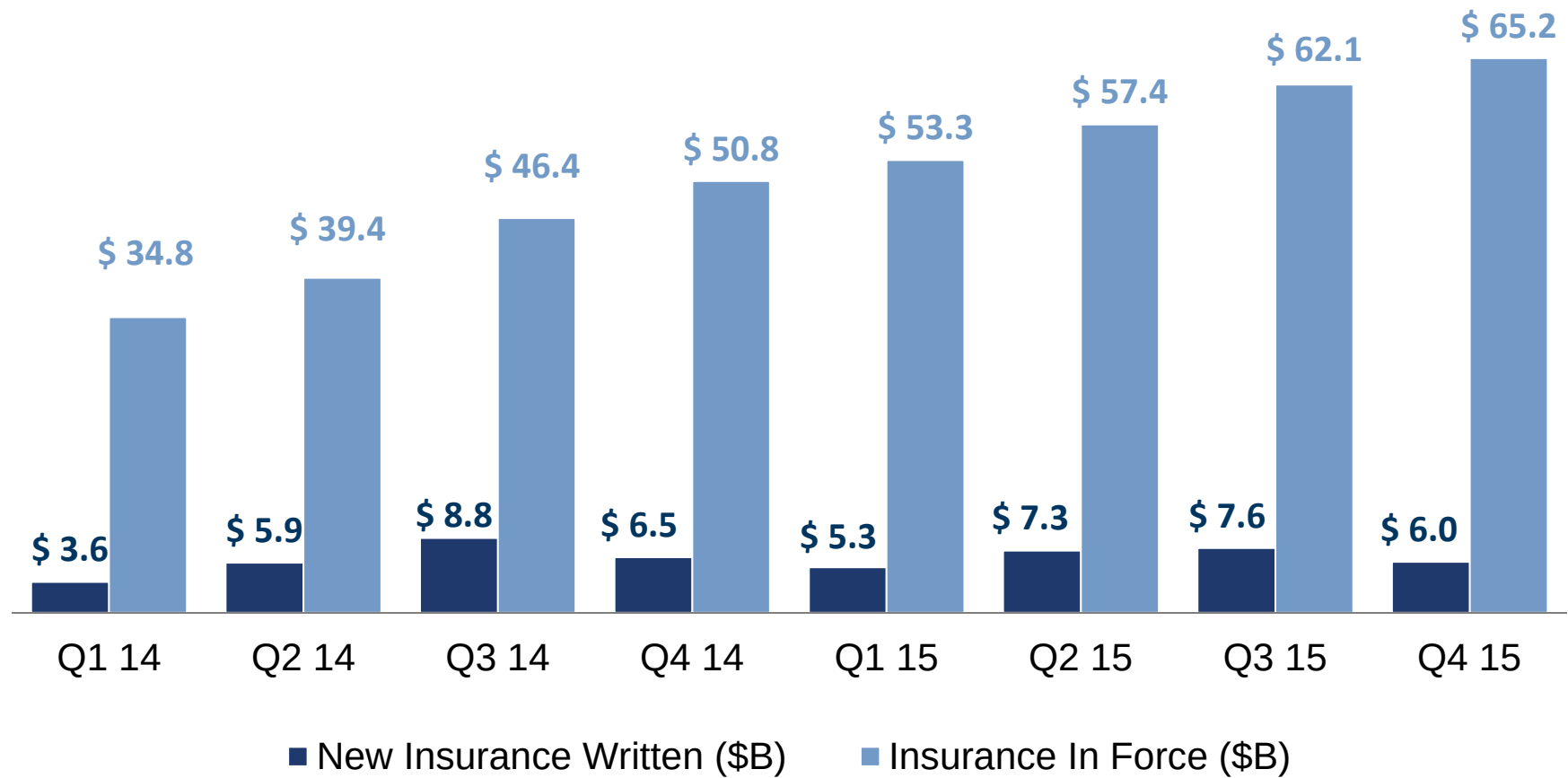
OTHER UNDERWRITING & OPERATING EXPENSES (\$M)



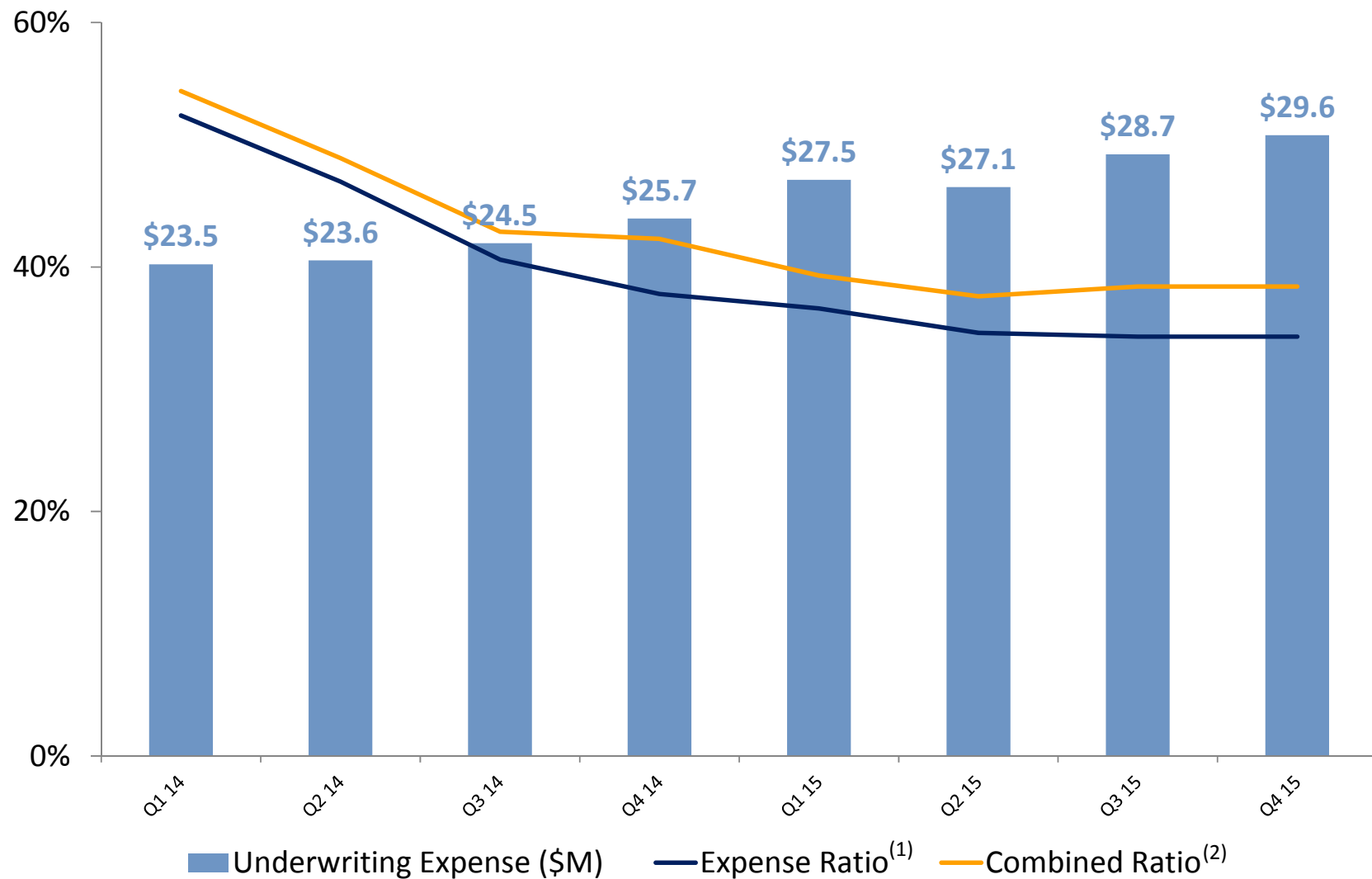
PRE-TAX INCOME (\$M)

Underwriting Expenses



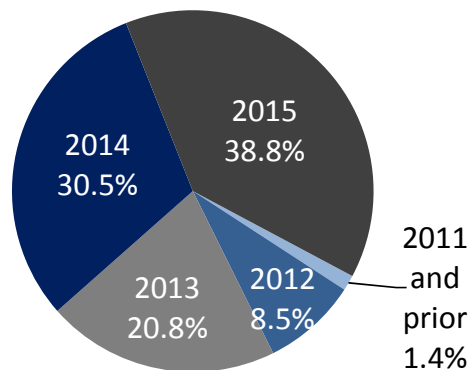

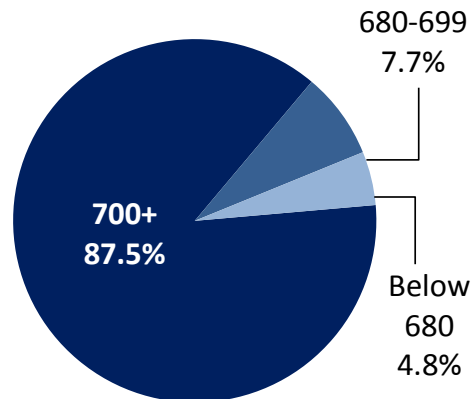

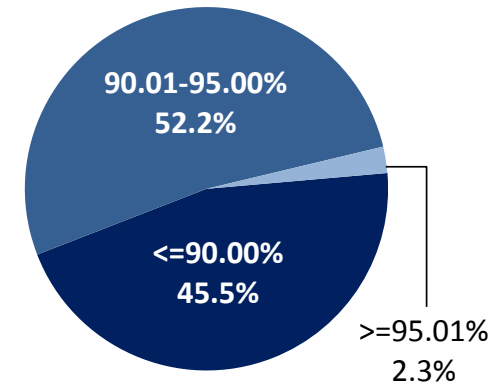
IIF BY VINTAGE



IIF by FICO Score

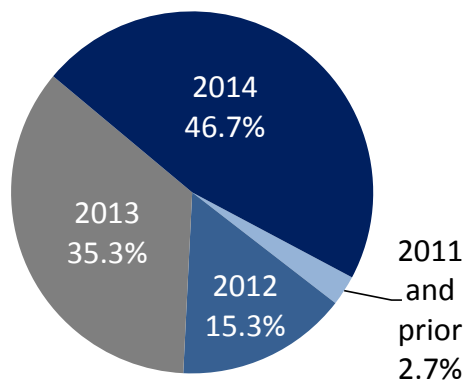


IIF BY LTV

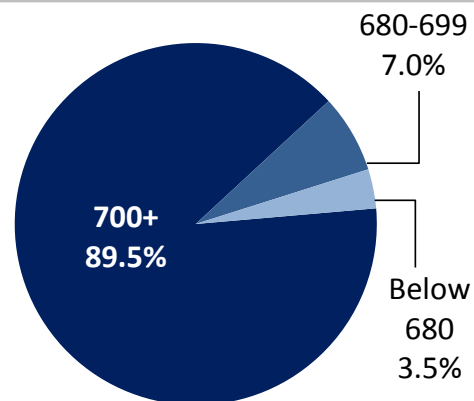


\$50.8 BILLION AS OF DECEMBER 31, 2014

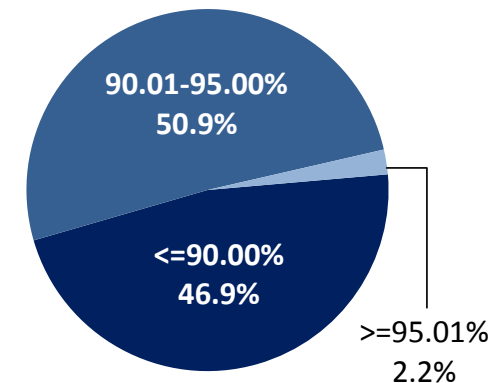

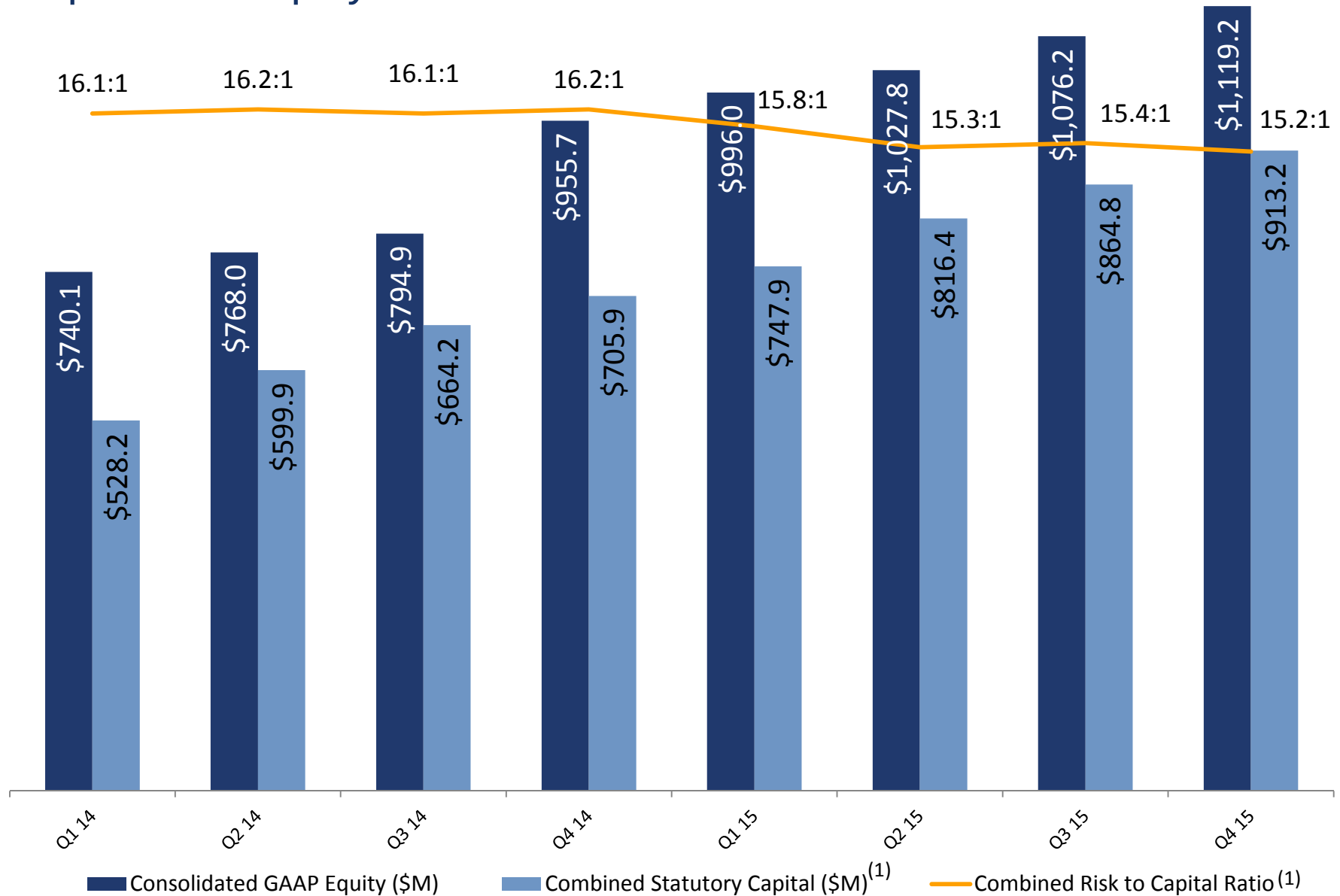
IIF by FICO Score
