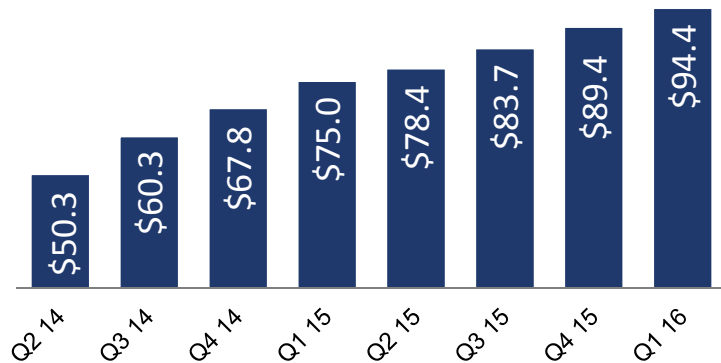

- Combined risk to capital ratio of 14.8:1⁽¹⁾



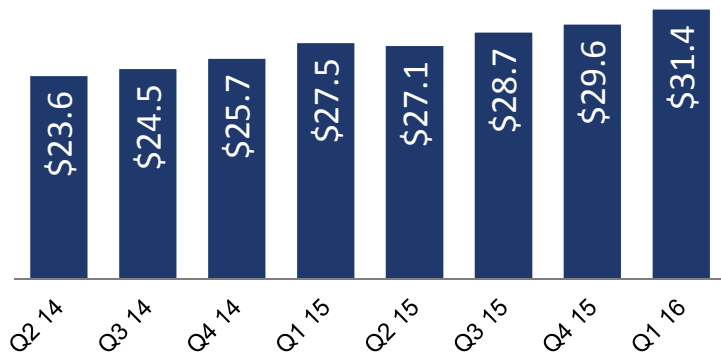

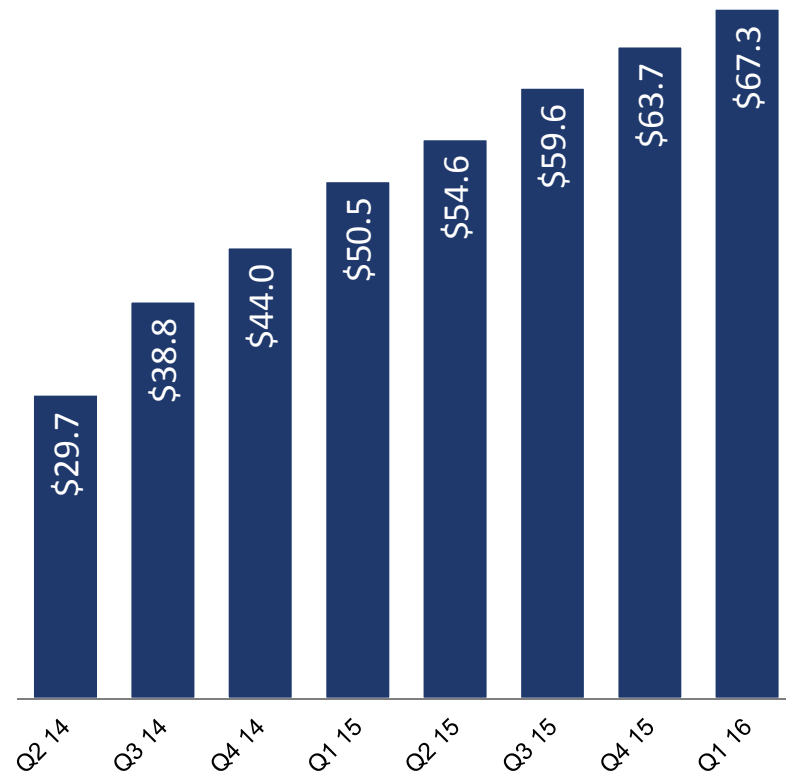
NET PREMIUMS EARNED (\$M)



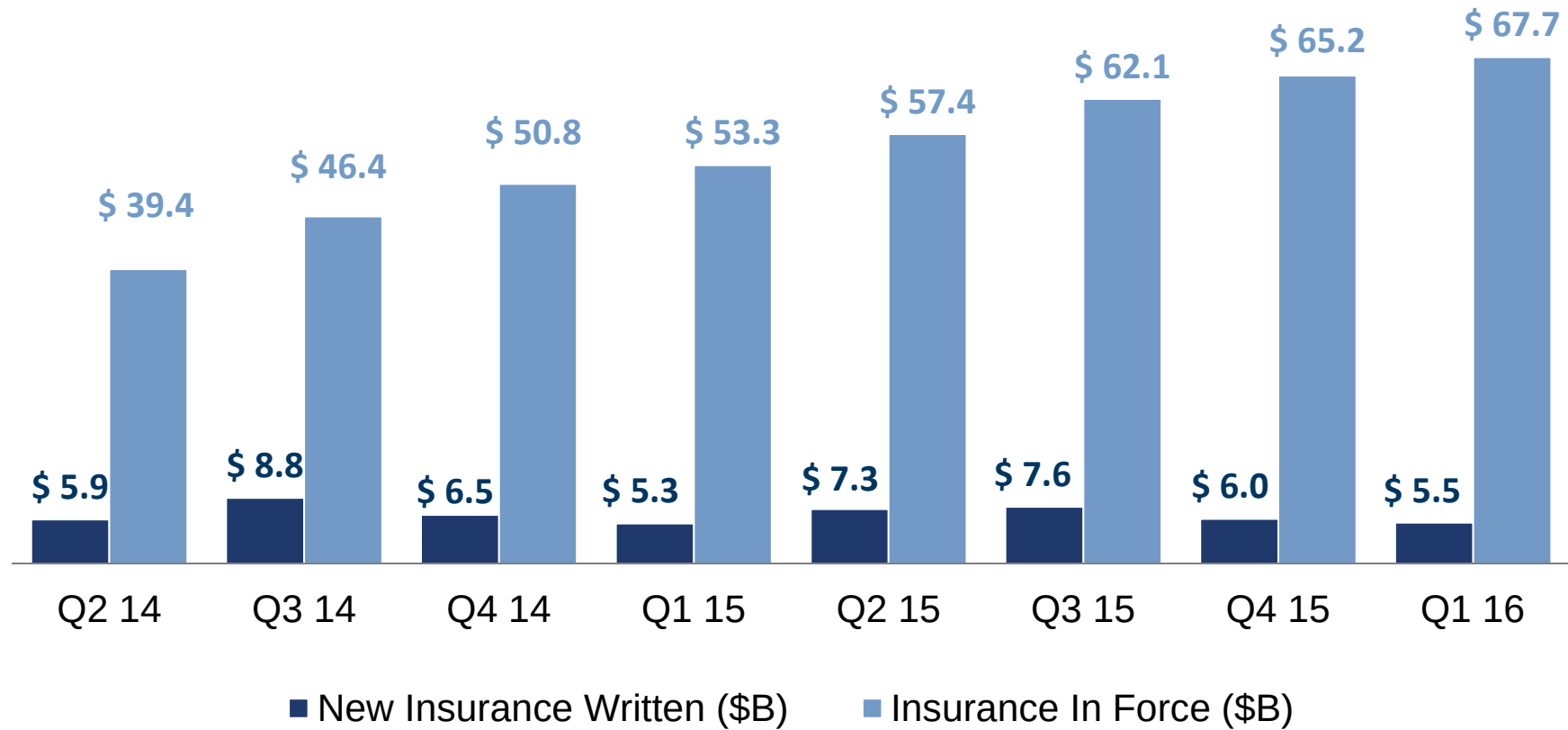
OTHER UNDERWRITING & OPERATING EXPENSES (\$M)



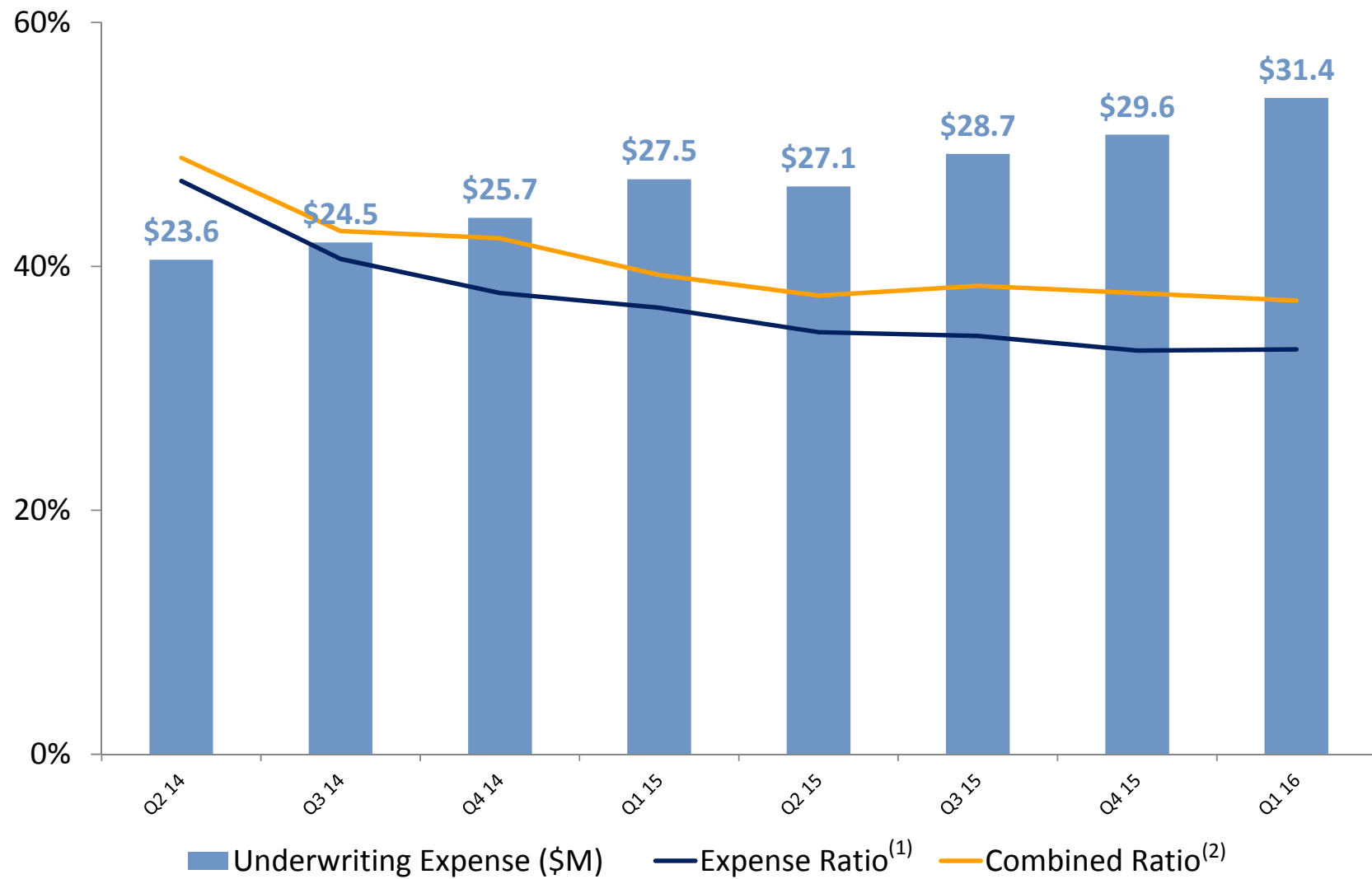
PRE-TAX INCOME (\$M)

Underwriting Expenses



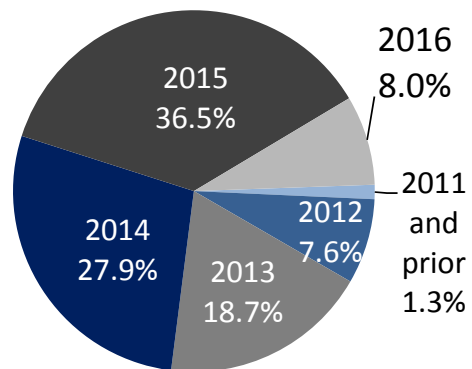

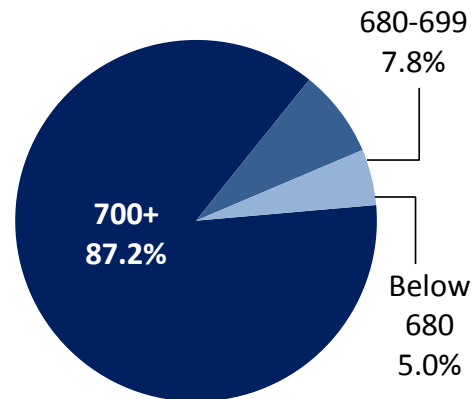

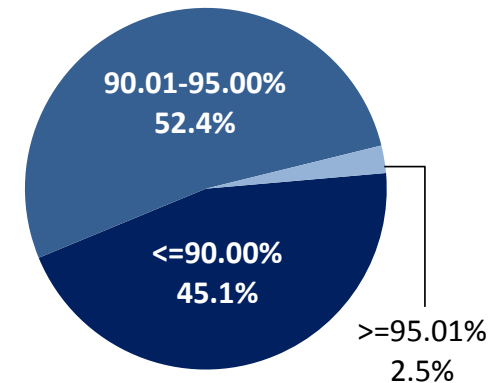
IIF BY VINTAGE



IIF by FICO Score

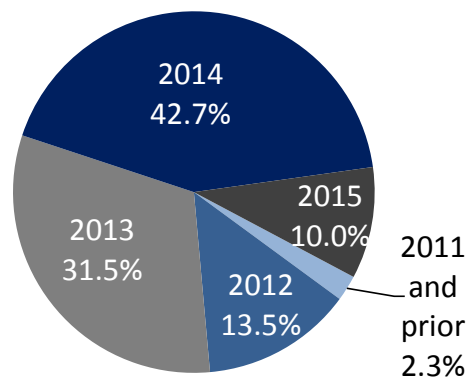


IIF BY LTV

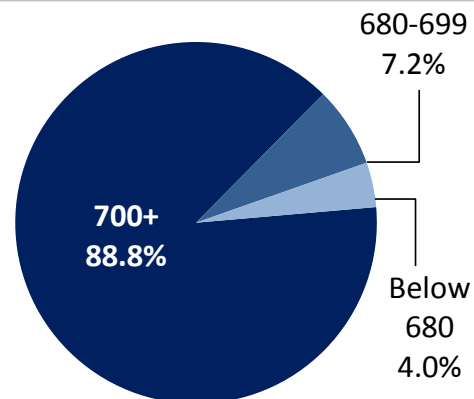


\$53.3 BILLION AS OF MARCH 31, 2015

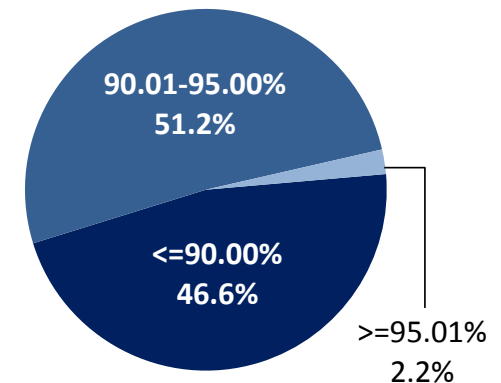

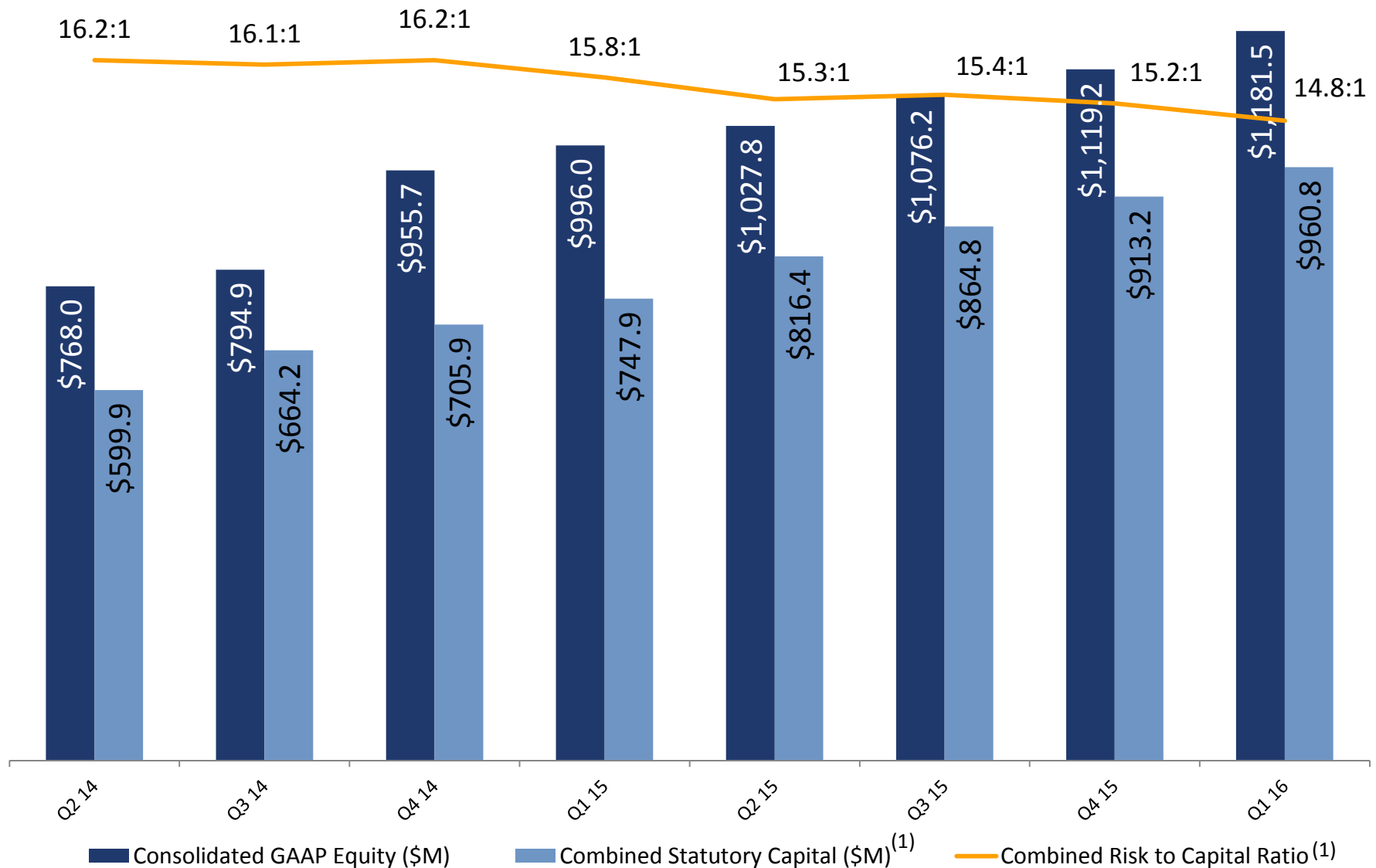
