Reserves as of December 31, 2012 were \$167,240. As of June 30, 2013, \$39,572 has been paid for incurred claims and claim adjustment expenses attributable to insured events of prior years. Reserves remaining for prior years are now \$70,236 as a result of re-estimation of unpaid claims and claim adjustment expenses. Therefore, there has been a \$57,432 favorable prior-year development since December 31, 2012 to June 30, 2013. The decrease is generally the result of favorable developments in the default status of underlying insured loans as well as ongoing analysis of recent default statuses and loss development trends. Original estimates are increased or decreased as additional information becomes known regarding individual claims. The Company does not adjust premiums based on past claim activity.

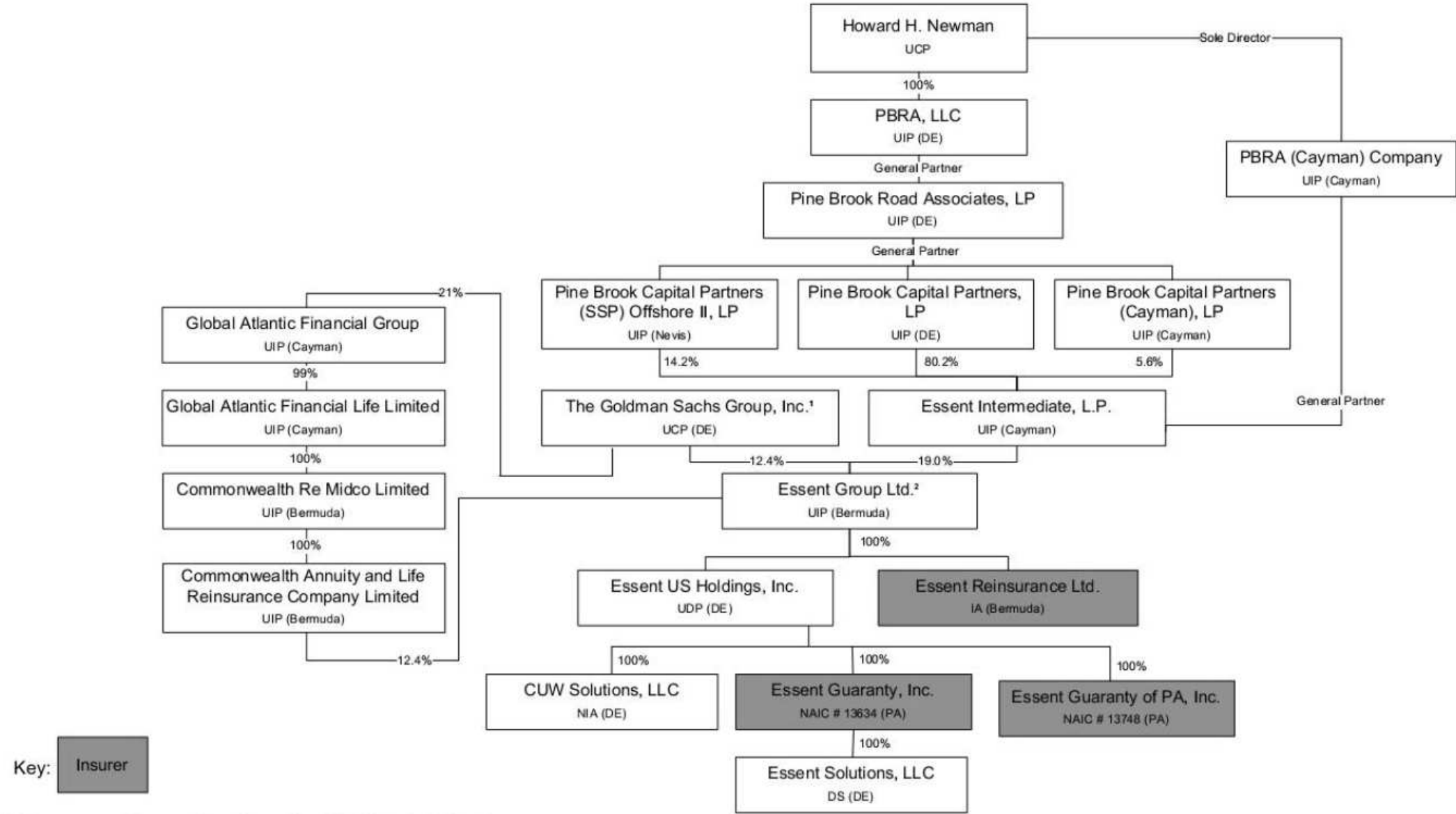

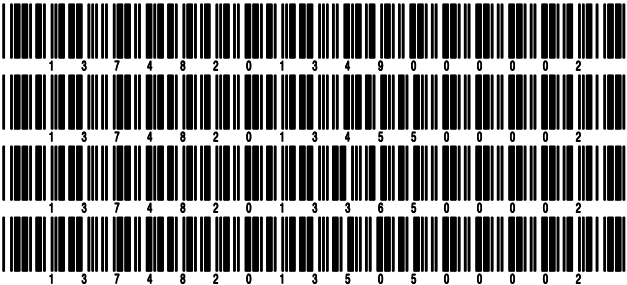
