TRANSACTION OVERVIEW

CEDING INSURER:	➤ On November 10, 2021, Essent Guaranty, Inc., a wholly owned subsidiary of Essent Group Ltd., obtained fully collateralized excess of loss reinsurance coverage on mortgage insurance policies written in April 2021 through September 2021. ➤ The total amount of reinsurance was \$439.4 million as of the closing date.
REINSURER:	➤ For this transaction, reinsurance is provided by Radnor Re 2021-2 Ltd. (“Radnor Re”), a newly formed Bermuda based special purpose insurer. Radnor Re is not a subsidiary or an affiliate of Essent Group Ltd. ➤ Radnor Re has funded its reinsurance obligations by issuing four classes of mortgage insurance-linked notes with 10-year legal maturities in an unregistered private offering. The notes are non-recourse to any assets of Essent Guaranty, Inc. or its affiliates. ➤ The proceeds of the notes offering were deposited into a reinsurance trust account for the benefit of Essent Guaranty, Inc. The noteholders have a subordinated interest in the reinsurance trust account, which is the sole source of funds for the repayment of the notes.

TRANSACTION HIGHLIGHTS

- Radnor Re collateralized and funded the reinsurance coverage by issuing \$439.4 million of mortgage insurance-linked series 2021-2 notes to investors.
- The reference pool has an aggregate unpaid principal balance of \$47.2 billion and risk in force of \$12.4 billion as of the September 30, 2021, cut-off date.
- The notes provide excess of loss protection to Essent Guaranty for four coverage levels designated as M-1A, M-1B, M-2, and B-1, with a funded percentage of 72.5% for M-1A and 70% for all other levels.
- The notes are SOFR-based floating rate securities with a 10-year legal maturity.
- Radnor Re used the Series 2021-2 note proceeds to purchase investments to fully fund the reinsurance trust post closing on November 10, 2021.
- Essent Guaranty, Inc., is required to make premium payments to Radnor Re to cover interest payments on the Series 2021-2 notes less investment income from the assets in the reinsurance trust.
- Essent Guaranty, Inc. has an option to call the transaction on and after November 25, 2027.
